Admissions Notification - 2025 Batch

ISBR Business School invites applications for the full-time/part-time Fellow Program in Management (FPM).

Eligibility Criteria

A. Candidates must hold a Master's degree or an equivalent qualification in Engineering and Technology, Management, Economics, Social Science, Biological Science, Pure Science, Commerce, or Humanities with **First Class** to be eligible for admission to the Fellow Program.

B. Candidates appearing for their final examination in the respective discipline may also apply. However, the deadline for submitting the final year mark sheet is **December 31, 2025**.

Admission Procedure

Applicants must submit their applications in the prescribed form available with the institution. Attested copies of all necessary certificates and testimonials must be attached to the application. Additionally, candidates must submit an abstract of approximately **5,000 words** on their area of research interest (tentative research proposal) along with their application.

Selection Criteria



The selection of candidates will be based on the following criteria:

- Academic qualifications and work experience
- Evaluation of the tentative research proposal and its presentation before the Selection Committee
- Personal interview

The decision of the Institution Selection Committee regarding admission shall be final. Only selected candidates will receive official communication. The institution shall not entertain any queries or correspondence regarding non-selection.

The duly completed application form, along with supporting documents (including a copy of a photo ID proof) and an **application fee of Rs. 2000/-**, should be submitted via:

- **Online transfer** or
- **Demand Draft** in favor of "ISBR Business School," payable at Bangalore.
